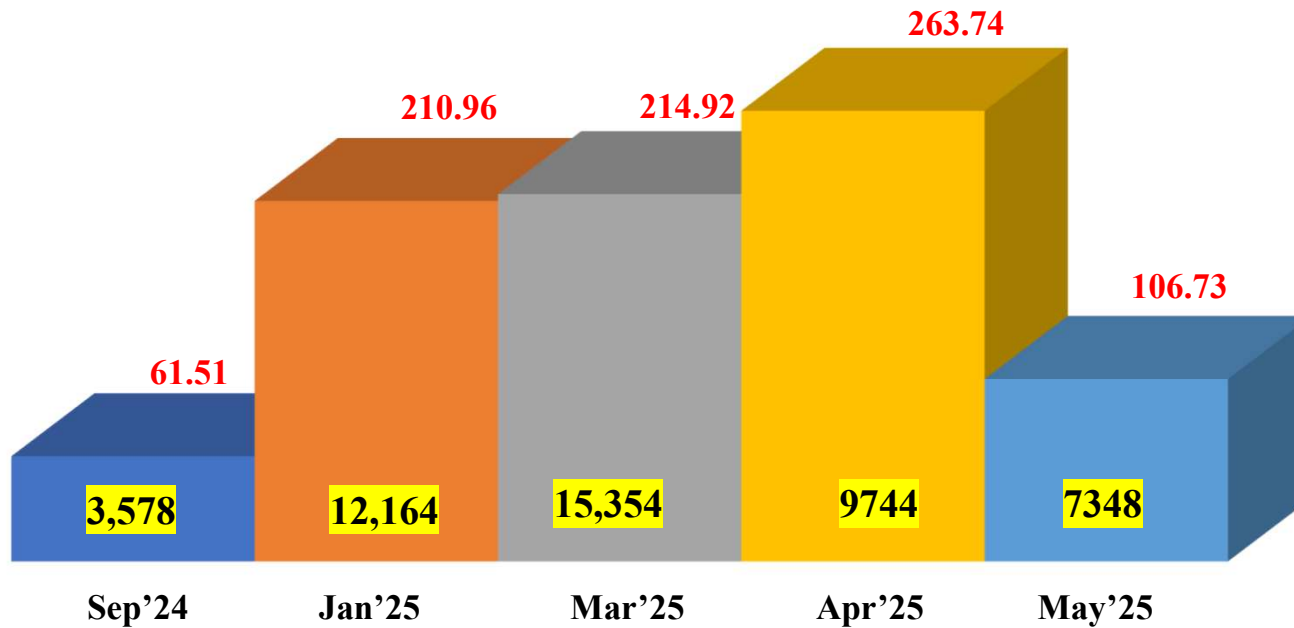

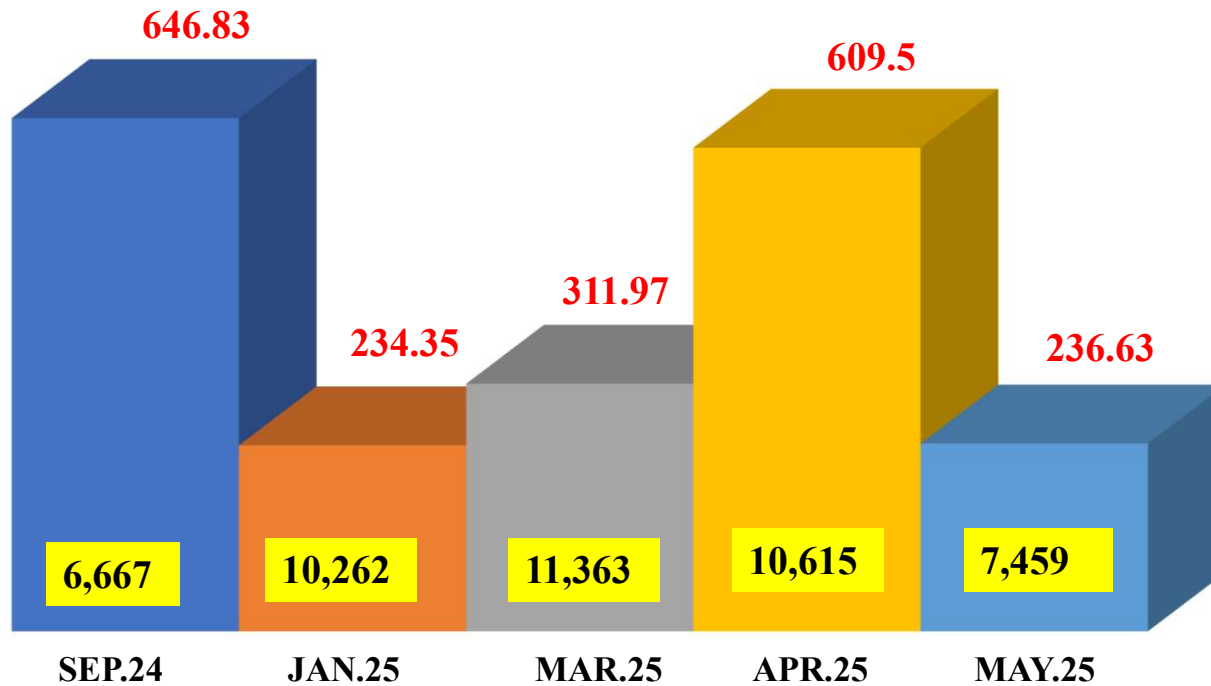

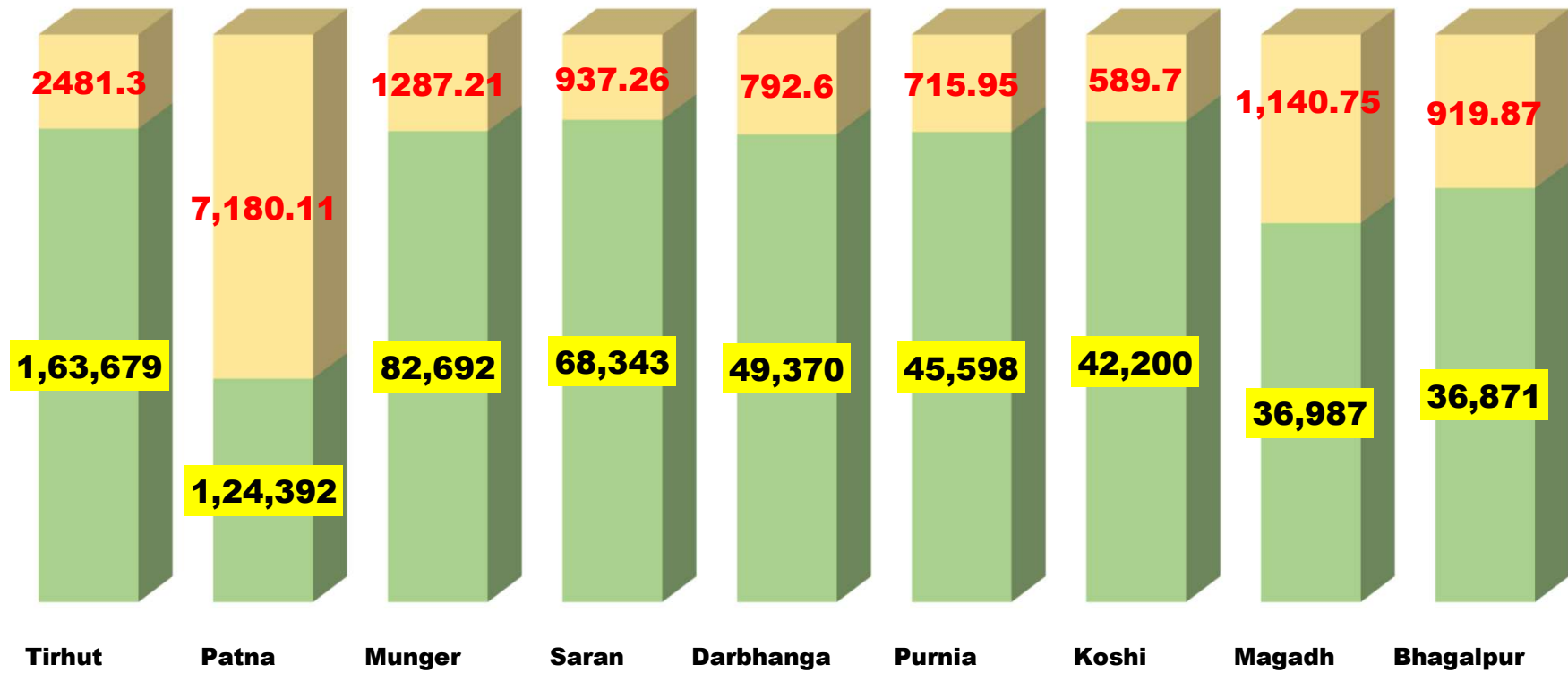

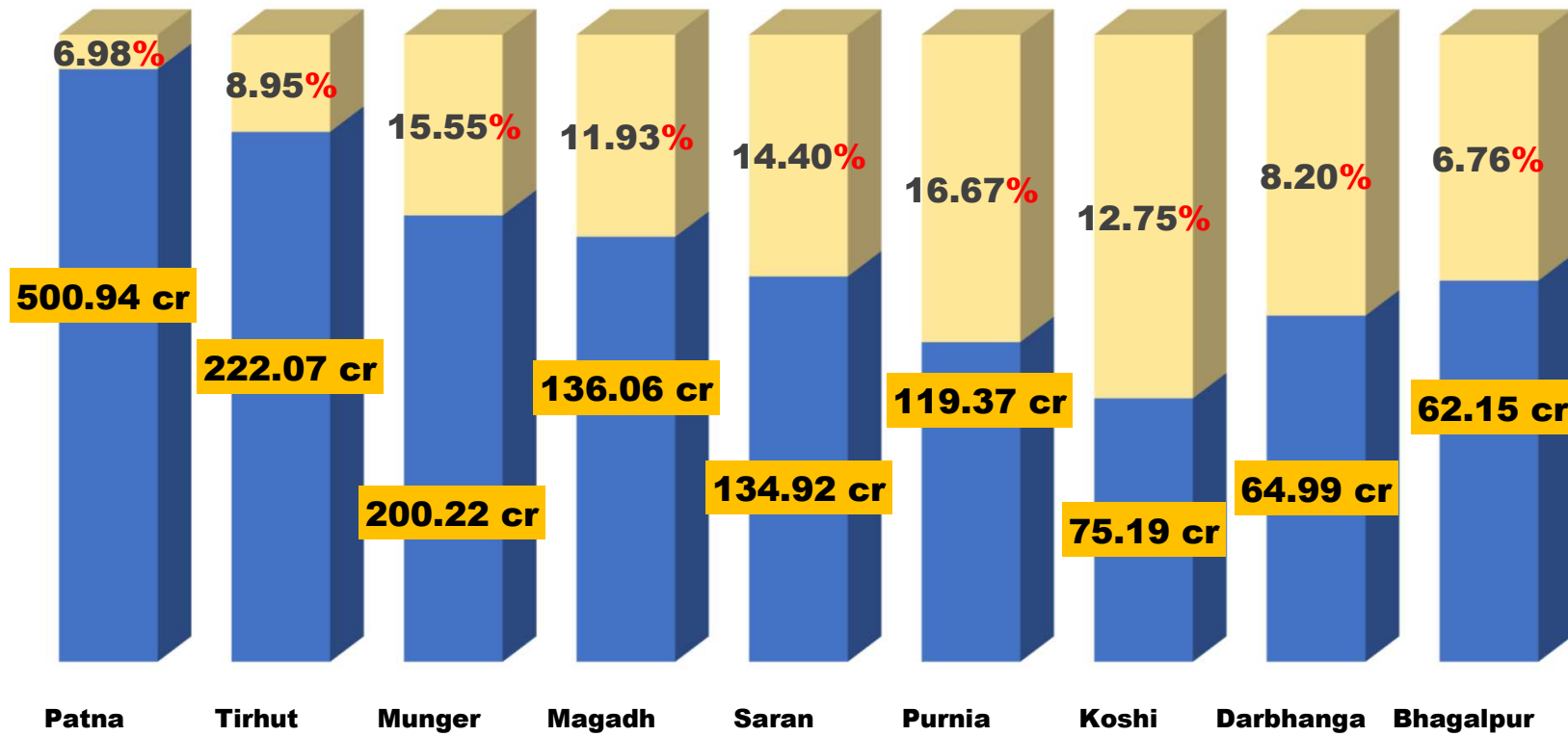

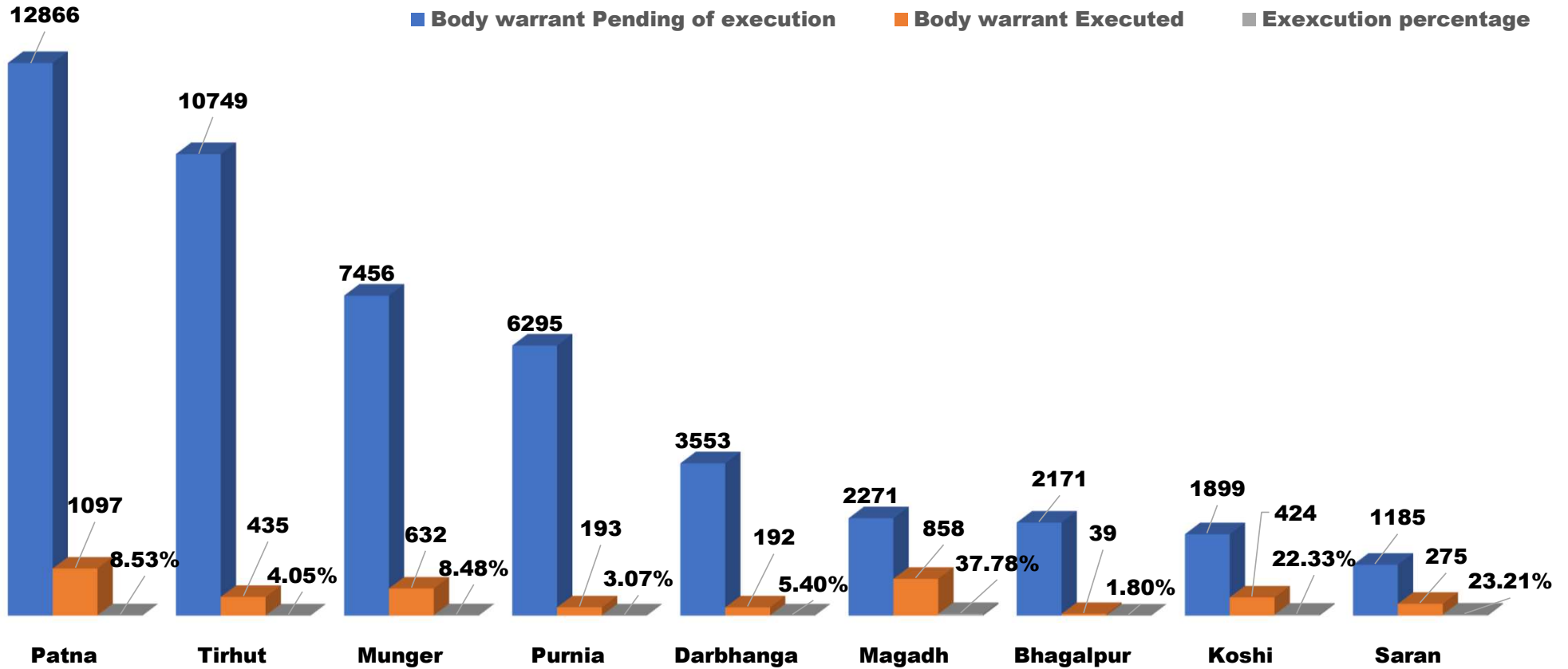


AMOUNT (Cr) RECOVERED & RECOVERY PERCENT Sep'24 to May'25

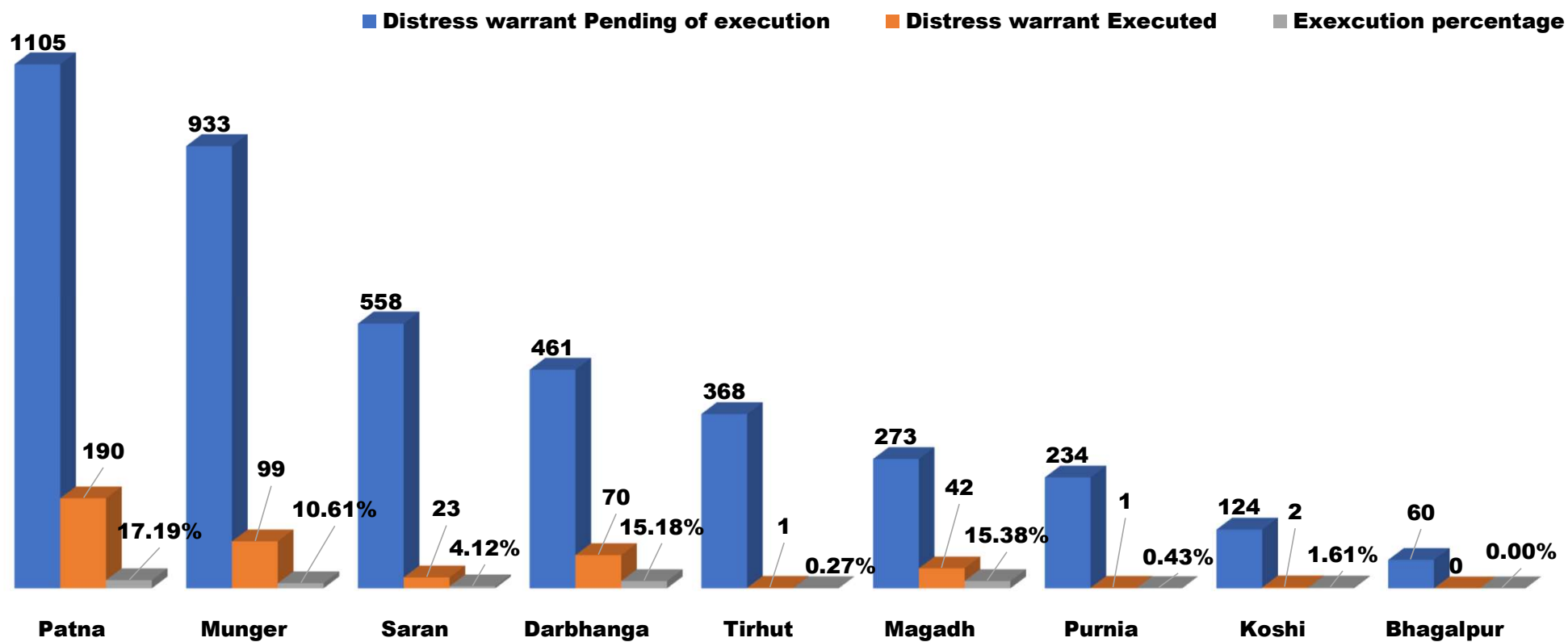

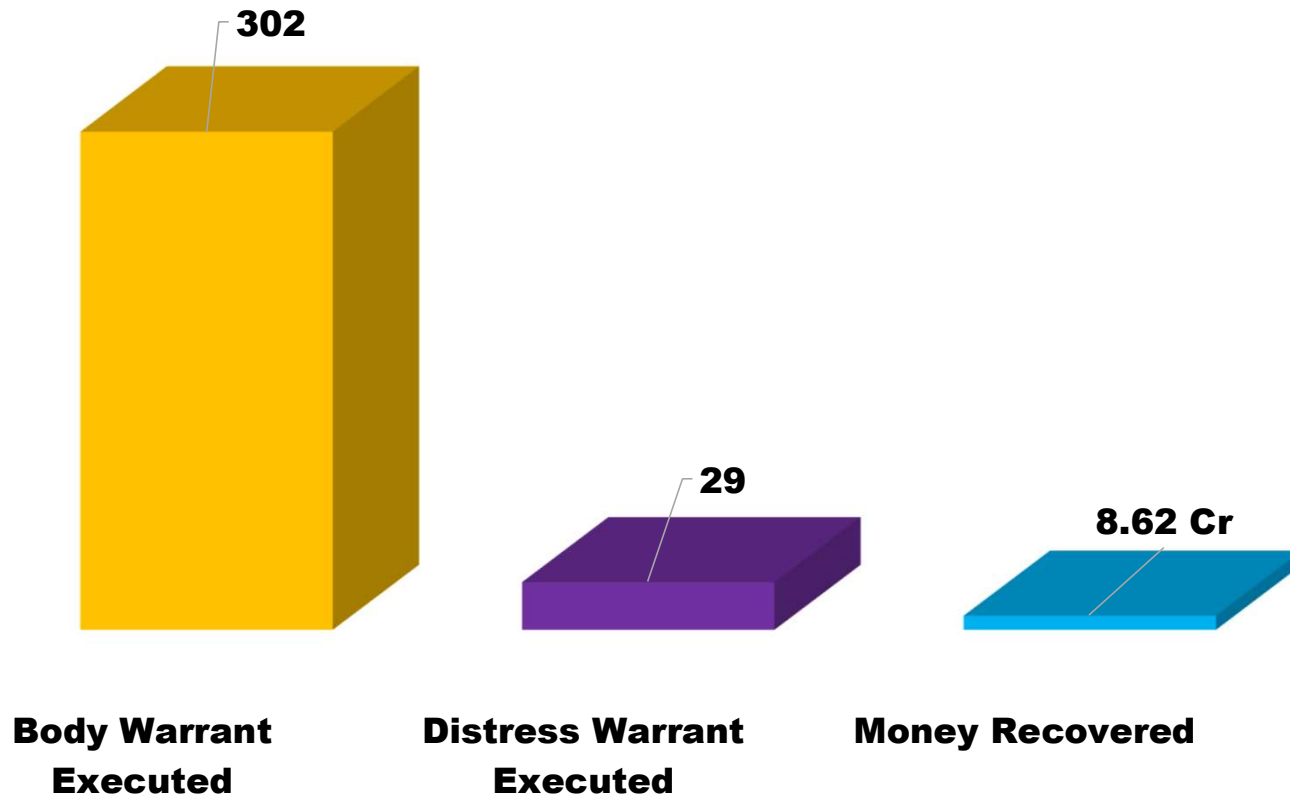
BODY WARRANTS PENDENCY, EXECUTION & EXECUTION PERCENTAGE AS ON 1.06.2025



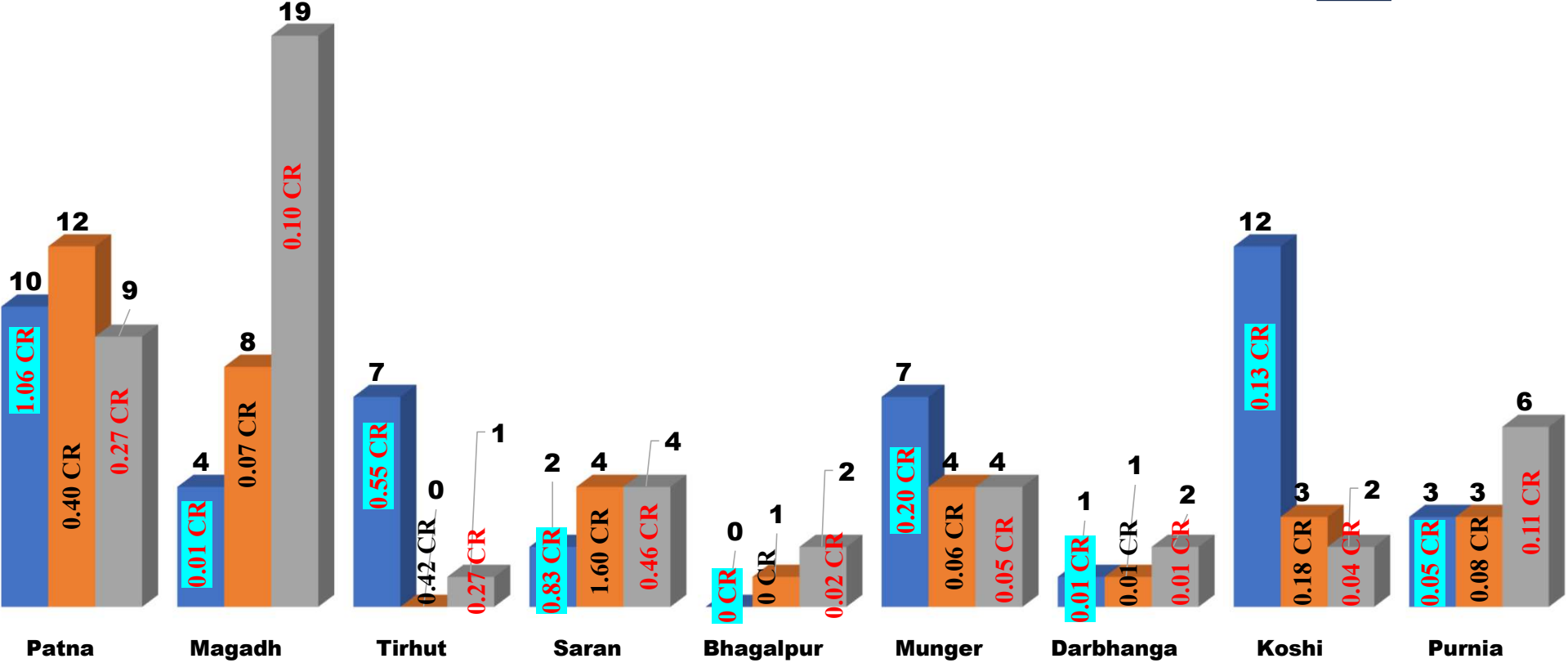
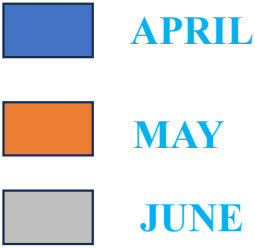
DISTRESS WARRANTS PENDENCY, EXECUTION & EXECUTION PERCENTAGE AS ON 1.06.2025



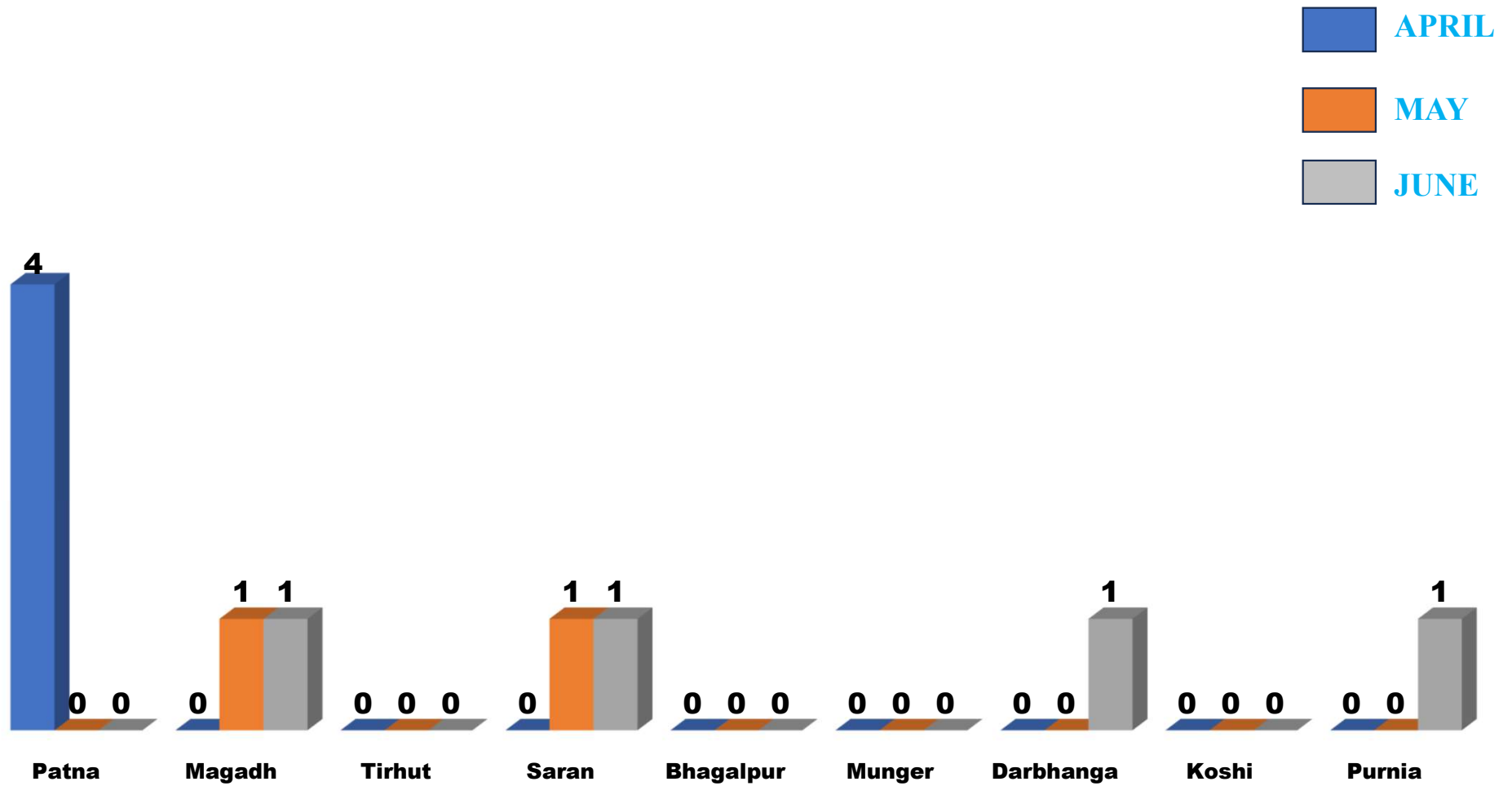
WARRANT WEEK STATUS OF STATE (02.06.2025 TO 06.06.2025)



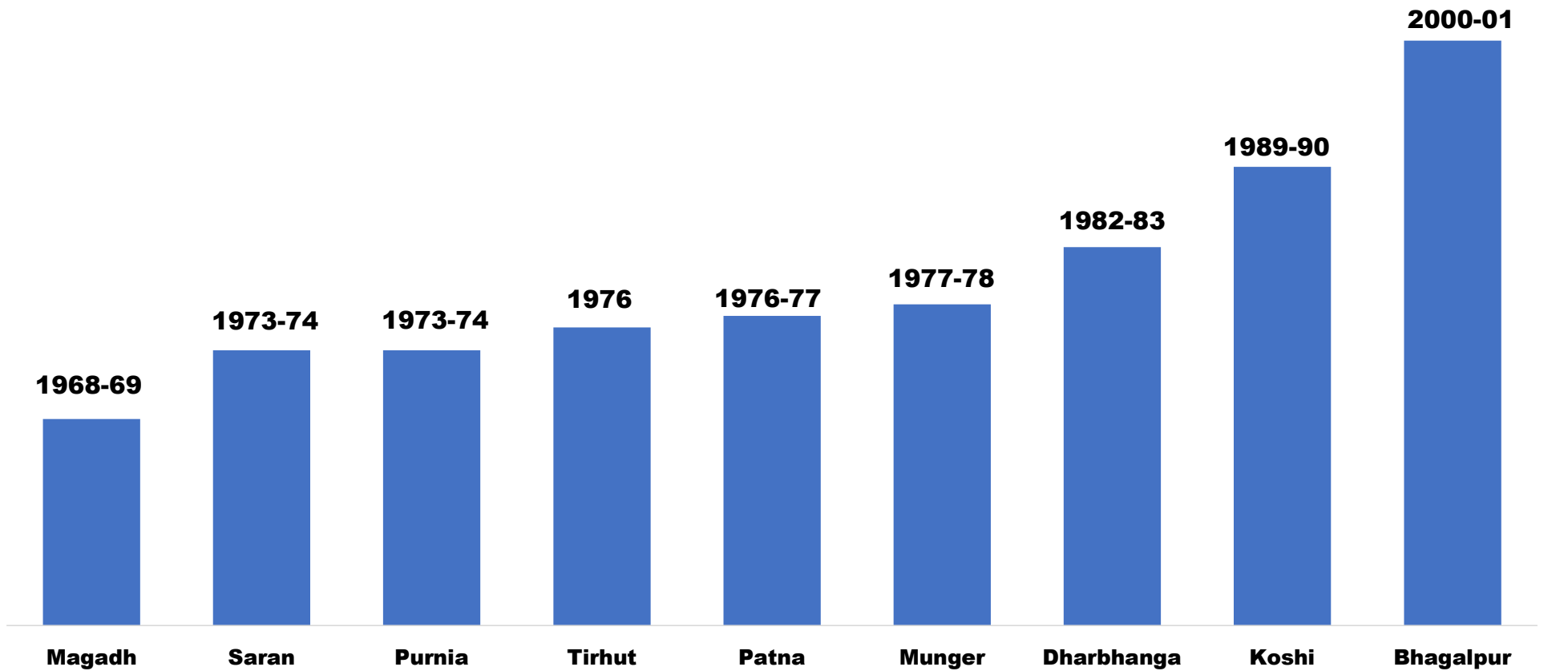
AVERAGE OF DAILY B/W EXECUTION & MONEY RECOVERY IN APRIL, MAY & Till 19th JUNE
